 - b. Itemized receipt/invoice that shows retailer/contractor name, address, phone number purchase and/or install date, quantity size, description, manufacturer, model, purchase price, and proof of payment.
- 4. IMPORTANT: Photocopy your entire submission for your records.
- 5. An Air Conditioning, Heating, & Refrigeration Institute (AHRI) certificate, including model number, capacity, and efficiency performance ratings. All minimum efficiency ratings must be met to qualify for rebate

HVAC Equipment Terms and Conditions

- 1. Equipment and services must be purchased and installed between June 1, 2021, and May 31, 2026.
- 2.. Rebate application must be submitted within 90 days of HVAC installation date and be postmarked or submitted online by June 6, 2026. Must submit one rebate application form per unit.
- 3.. It is the responsibility of the customer to assure that all requirements for the rebate are met. Failure to provide any of the required information will prevent processing of your application.
- 4. Rebate payments are based on the equipment installation date. Customers must abide by the rules and rebate levels in effect on the date of installation. Rebate levels cannot exceed the cost of equipment.
- 5. Purchase must be of a qualified high-efficiency electric central air conditioner, heat pump, geothermal heat pump or ductless mini split heat pump as defined in the table on this rebate application form. Both the condenser and coil/indoor unit must be replaced and installed as a matched set as defined by AHRI.
- 6. HVAC system must be rated in the AHRI database. AHRI certificate must include all installed components, as stated on invoice. Values stated on AHRI certificate must meet minimum program qualifications. For example, a condenser may have an "up to 15 SEER" rating, but when matched with a compressor and furnace, the system may only reach 14.5 SEER as determined by AHRI. Ask your contractor for more details. AHRI ratings for individual components of a system will not be considered valid. Existing furnaces cannot be listed on the AHRI Certificate. System must provide domestic space heating and cooling only.
- 7. System must provide domestic space heating and cooling only.
- 8. Duquesne Light and/or their designees including program administrators and evaluation contractors reserve the right to review installations to verify completion and measure energy savings to ensure compliance with all program requirements. Such reviews will be made at a time convenient to the applicant. Misrepresentation of installation location or measure eligibility may result in forfeiture of the rebate.

- Program procedures, requirements and rebate levels are subject to change or cancellation without notice and are subject to available program funds.
- 10. Payment will be issued by check and to the account holder at mailing address on record with the utility or to submitting contractor as assigned by customer through their signature on this rebate form.
- 11. Please allow a minimum of 30 days from the date all required information is received to process your rebate(s).
- 12. Installations must be completed in accordance with all laws, codes and other requirements applicable under federal, state and local authority.
- 13. Your rights to this rebate cannot be assigned or transferred. Excessive submissions constitute fraud and may result in federal prosecution under the U.S. mail fraud statutes (Title 18, USC 1341 and 1342). All submitted materials become the property of Duquesne Light and will not be returned.
- 14.
